Parent Provider Agreement COVID 19

During this difficult and stressful time, we at Anthony's Bilingual Preschool want you to know that we value the safety and wellbeing of you and your child(ren). For this reason, we ask that you take time to read through the following statements that we will put in place to keep everyone healthy and safe:

- If you meet any of the following criteria, please do not visit or pick-up/drop-off a child at our program:
 - Older than 60 years old,
 - Pregnant, if have underlying health conditions,
 - Have underlying health conditions, including those with compromised immune systems or respiratory conditions like severe asthma,
 - Have symptoms of COVID-19 (fever, cough, shortness of breath),
 - Have been in contact with someone with COVID-19 in the last 14 days, or
 - Have returned from travel to areas with community spread of COVID-19 as defined by the CDC in the last 14 days
- When picking up or dropping off a child(ren), please wait outside and a teacher/staff person will assist you. Please note that you will be asked to stagger your arrival/departure times; Anthony's Bilingual Preschool will work this out with you ahead of time. We also ask that you practice "social distancing" (6 feet) at all times.

- Parents who picking up or dropping off are required to wear face masks and gloves.

- If you need to enter the program for any reason, we ask that you wash and sanitize your hands immediately upon entry.
- If your child becomes ill while in our program, you will be asked to pick-up your child within one hour of the program contacting you. Please have plans in place to ensure you or a designated person is available if this should occur.
- If your child has been in contact with someone with COVID-19 in the last 14 days, become infected with the COVID-19 <u>as defined by the CDC</u> or has been symptomatic. Your child must not attend Anthony's Bilingual Preschool
- Please review your enrollment information to ensure we have your current contact information as well as emergency contact information.

- <u>Exclusion criteria</u> if a child have a cough but no other symptoms a child must stay home until 48 hours after the cough has ended.
- If a child showing any other symptoms, please keep your child home until confirm no contagion. We ask parents to bring a doctors note saying a child is COVID free. A child must stay home until 48 hours after the last symptom has ended.
- <u>Tuition:</u> will be charged in full the Days that your child does not attend school due to any disease. And when Anthony's Bilingual Preschool is closed due to grave unforeseen circumstances beyond either parties' control.

ADDITIONAL PROVISIONS

- Staff will take a temperature every day on a child forehead. If a child measure fever a child will not be admitted at school.
- Staff WILL change clothes every day at Anthony's Bilingual Preschool at the beginning of the day and at the end of the every workday.
- Staff will call parents and isolate a child at the first sign of illness.
- Cloth items used in the classroom will be sent home to laundered everyday.
- All use surfaces will be disinfected daily.
- Children WILL NOT wear face masks because a child would not be comfortable, and children would not do well, because it might cause a sensory issue.
- Staff WILL always wear face masks and gloves while in contact with children or other staff and Staff will maintain a 6ft distance.
- Regular disinfection of all surfaces used throughout the day such as kitchen and bathroom.
- Six-foot distance will be maintained from bed to bed.
- Children will be outdoor as much as possible and windows will be open to circulate air.
- Visitors will be restricted until further notice.
- Enhance cleaning and disinfecting items/toys in between use and throughout the day.

By signing this agreement, I am fully committed to social distancing. And I understand that everyone in our preschool community will practice safe social distancing, and so I would be reassured to know that other families are committed to do this too.
